EXPRESSION OF INTEREST FOR SELECTION OF SYSTEM INTEGRATOR FOR IMPLEMENTATION OF CCTNS ODISHA

The Crime and Criminal Tracking Networks & Systems (CCTNS) is a Mission Mode Project (MMP) of Ministry of Home Affairs which intends to enhance the efficiency and effectiveness of the functioning of Police Department. Government of Odisha would like to invite a response to EOI from the interested bidders.

DETAILS ABOUT THE CCTNS PROJECT IS AVAILABLE ON WWW.NCRB.GOV.IN

1. Geographic Coverage:

CCTNS in the State will cover around 579 Police Stations spreading across 36 Police Districts. In addition to this CCTNS coverage includes 96 SDPO Offices, 36 District Police Control Room and 1 State Police Control Room, 48 Training Centers, 9 Ranges, 16 ACP Offices, 1 Forensic State Lab, 1 Finger Print Bureau, 1 State Crime Record Bureau, 1 Commissioner Office and Police Headquarter etc. The above number of Offices/Police Stations is indicative which may increase during the plan period as per decision of the State Government.

Scope of Work

The Indicative Scopes of work for the System Integrator would include the following components of the project:

- Project planning and management.
- Configuration Customization and Extension (New Modules) of CAS (State) and Integration with CAS (Center) and External Agencies. CAS (State) will be developed in two distinct technology stacks by the SDA at the Center. The SI is expected to bid with one of the technology stacks in the response to this RFP. SI shall procure all the necessary underlying solution components required to deploy the CAS (State) solution for the State/UT.
- Site preparation and IT Infrastructure at the Client site locations (Police Stations, Commissionerate, Range Offices, ACP Offices, SCRB, SDPOs, District HQ and State HQ etc.), Training Centers and Data Center.
- Change Management.
- Capacity Building exercise which would include providing training to the selected staff/officials and to draw up a systematic training plan in line with the overall project plan. The number of staff/ officials to be trained would be approximately 28000(approx.).
- Support to 3rd party acceptance testing, audit and certification in implementing the above, the SI shall strictly adhere to the standards set by the MHA, NCRB, and State.
- Digitization of legacy records and migration of the data already available in the existing system
 to the new system. There would be approximately 24-26 lakh numbers of records/pages for
 digitization or entry.
- Handholding to the Police Personnel at each Police Stations for minimum of 6 months.

3. CAS customization & Development of Functionalities

 Partner for discussion on their proposed solution/offering for implementation of CCTNS in
 Odisha.

- This invitation for Expression of Interest does not call for a solicitation. Odisha Police Reserves
 the right to change or cancel the requirement at any time during the EOI and/or Solicitation
 process. Odisha Police also reserves the right to seek other Compliance Norms with additional
 conditions as and when the final solicitation documents are issued.
- The decision of Odisha Police shall be final and binding.
- The EOI does not constitute a commitment to an offer of a Contract or prospective Contract.
- Odisha Police shall not be liable for any cost incurred by any potential participant in preparation and submission of information in response to this invitation for EOI.
